

ORDINANCE NO.	

AN ORDINANCE to amend the Official Zoning Map of the City of Des Moines, Iowa, set forth in Section 134-277 of the Municipal Code of the City of Des Moines, Iowa, 2000, by rezoning and changing the district classification of certain property located in the vicinity of 4801 Franklin Avenue from the Limited "C-1" Neighborhood Retail Commercial District to the "PUD" Planned Unit Development District classification.
