WHEREAS, twenty-one (21) Ford Utility Interceptors for use by the Police Department have been competitively bid and are available from Stivers Ford, 1450 E. Hickman Road, Waukee, IA 50263, Scott Politte, General Manager, per State of Iowa Contract 19154 at a total cost of \$683,697.00; and

WHEREAS, \$112,356.00 of the funding is available from FN024865/Fire Equipment Replacement, and \$683,697.00 is available from FN024869/Police Equipment Replacement; and
