AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2836, 114-2893.05, 114-3262, 114-3410 and 114-3567, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2836, 114-2893.05, 114-3262, 114-3410 and 114-3567, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2836. Twenty-sixth Street--Woodland Avenue to Ashby Avenue.**

Twenty-sixth Street, on the east side, from Woodland Avenue to a point 50 feet north thereof, no parking any time.

Twenty-sixth Street, on the west side, from Woodland Avenue to a point 250 feet north of Rollins Avenue, no parking any time.

Twenty-sixth Street, on the east side, from a point 250 feet south of School Street to School Street, no parking 8:00 a.m. to 5:00 p.m., Monday through Friday.

Twenty-sixth Street, on the east side, from School Street to Kingman Boulevard, no parking any time.

Twenty-sixth Street, on the east side, from Kingman Boulevard to University Avenue, no parking any time.

Twenty-sixth Street, on the west side, from University Avenue to a point 20 feet south thereof, no parking any time.

Twenty-sixth Street, on the west side, from Carpenter Avenue to a point 50 feet south thereof, no parking any time.

Twenty-sixth Street, on the east side, from Forest Avenue to a point 550 feet north of Clark Street, no parking any time.

Twenty-sixth Street, on the west side, from Washington Avenue to Franklin Avenue, no parking any time.

Twenty-sixth Street, on the east side, from Franklin Avenue to a point 50 feet south thereof, no parking any time.

Twenty-sixth Street, ~~on the west side~~ both sides, from Lincoln Avenue to Hickman Road, no parking any time.

Twenty-sixth Street, on the east side, from Hickman Road to Holcomb Avenue, no parking any time.

Twenty-sixth Street, on the west side, from a point 200 feet north of Hickman Road to a point 200 feet north thereof, no parking any time.

Twenty-sixth Street, on the west side, from Holcomb Avenue to Mann Avenue, no parking any time.

Twenty-sixth Street, on the west side, from Payne Road to a point 50 feet north thereof, no parking any time.

Twenty-sixth Street, on the east side, from Payne Road to Arnolds Road, no parking any time.

Twenty-sixth Street, on the west side, from a point 165 feet north of Payne Road to a point 175 feet north and west thereof, no parking any time.

Twenty-sixth Street, on the east side, from Boston Avenue to Ashby Avenue, no parking any time.

Twenty-sixth Street, on the west side, from Ashby Avenue to a point 50 feet south thereof, no parking any time.

**Sec. 114-2893.05. Southeast Thirty-fifth Court--Evergreen Avenue to Dead End.**

Southeast Thirty-fifth Court, on the east side, from Evergreen Avenue to the dead end south of East Philip Street, no parking any time.

**Sec. 114-3262. Grand Avenue--Twenty-eighth Street to Thirty-first Street.**

Grand Avenue, on the north side, from Twenty-eighth Street to a point 260 feet west thereof, no parking any time.

Grand Avenue, on the north side, from a point 450 feet west of Twenty-eighth Street to Thirty-first Street, no parking any time.

Grand Avenue, on both sides the south side, from Twenty-eighth Street to Thirty-first Street, no parking any time.

**Sec. 114-3410. Lincoln Place Drive--John Lynde Road to Southwest Forty-second Street.**

Lincoln Place Drive, on the south side, from John Lynde Road to Southwest Forty-second Street--River Oaks Drive, no parking any time.

Lincoln Place Drive, on the north side, from a point 530 feet east of Southwest Forty-second Street, to a point 190 feet west thereof, no parking any time.

**Sec. 114-3567. East Philip Street--South Union Street to Dead End.**

East Philip Street, on the north side, from South Union Street to Southeast Third Court, no parking any time.

East Philip Street, on the south side, from Southeast Tenth Street to Southeast Thirteenth Street, no parking any time.

East Philip Street, on the south side, from Southeast Twenty-second Street to Southeast Twenty-third Street, no parking any time.


East Philip Street, on the north side, from Southeast Twenty-third Court to Southeast Twenty-fourth Street, no parking any time.

East Philip Street, on the north side, from Southeast Thirty-fourth Street to the dead end east of Southeast Thirty-fourth ~~fourth~~ fifth Court, no parking any time.
