APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE COMPETITIVE REQUEST FOR PROPOSAL (RFP) PROCESS FOR GOOD CAUSE AND APPROVING RENEWAL AMENDMENT FOR AUTOMATED TRAFFIC ENFORCEMENT (ATE) SERVICES CONTRACT WITH SENSYS GATSO USA, INC.

WHEREAS, Roll Call No. 10-1169, dated July 12, 2010, approved an RFP Evaluation and Selection Committee's Recommendation for Award of contract for the provision of Automated Electronic Speed and Red Light Enforcement Cameras & Citation Processing Services to GATSO USA, INC. now operating as SENSYS GATSO USA, INC., and authorizing the Police Department to negotiate and the City Manager to execute, a contract for the provision of the same; and

WHEREAS, the City of Des Moines Police Department wishes to utilize the same contract for the same purpose that City staff has negotiated with GATSO USA, INC., and amend for a three year additional term with an optional three-year extension, and reducing the service fees to be paid by the City to \$25 per red light citation and \$23 per speed citation, a copy of which is on file in the City Clerk's Office; and

WHEREAS, the City Manger recommends that the procurement of Automated Traffic Enforcement (ATE) services be exempted from the competitive bid requirements for good cause shown, pursuant to section 2-710(a) of the Municipal Code of the city of Des Moines; and

WHEREAS, funding for the \$25 per paid red-light citation and the \$23 per paid speed citation is available from the Police department operating budget.

NOW, THEREFORE, BE IT RESOLVED, that good cause has been shown to exempt the procurement of ATE services from the Procurement Ordinance competitive bidding requirements.

BE IT FURTHER RESOLVED that the Des Moines City Council hereby accepts and approves the procurement of ATE services for the Police Department under the above described amendment to the SENSYS GATSO USA, INC. contract, a copy of which is in the City Clerk's Office and the City Manager is authorized and directed to execute such amendment to the contract on behalf of the City and renewal thereof.


