## APPROVING AND AUTHORIZING THE EXECUTION OF UNION PACIFIC RAILROAD COMPANY (UPRR) SUPPLEMENTAL AGREEMENT FOR THE E. 30<sup>th</sup> STREET VIADUCT REHABILITATION

WHEREAS, the Union Pacific Railroad Company (UPRR) owns and operates a railroad within the area near and adjacent to the E. 30<sup>th</sup> Street Viaduct Rehabilitation Project; and

WHEREAS, the E. 30<sup>th</sup> Street Viaduct Rehabilitation includes construction of roadway and bridge improvements adjacent and over the UPRR rail lines; and

WHEREAS, the UPRR has presented a Supplemental Agreement that includes:

- 1. Temporary construction easements for rehabilitation, at a cost of \$12,500.
- 2. Railroad provided engineering inspection and review, at an estimated cost of \$35,000.

NOW, THEREFORE, BE, AND IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

- 1. That the Supplemental Agreement between the Union Pacific Railroad Company and City of Des Moines in connection with the E. 30<sup>th</sup> Street Viaduct Rehabilitation Project, copies which are now on file in the office of the City Clerk, be and is hereby approved as to form and content.
- 2. That the Mayor and City Clerk are hereby authorized and directed to execute said Agreement for and on behalf of the City of Des Moines, Iowa.
- 3. That the Engineering Department is hereby authorized to administer the terms of said Agreement.
