RESOLUTION APPROVING ISSUANCE OF A CERTIFICATE OF COMPLETION TO HELENA INDUSTRIES, INC., FOR THE EXPANSION OF ITS INDUSTRIAL FACILITY AT 3525 VANDALIA ROAD

WHEREAS, Helena Industries, Inc. ("Helena"), is a multi-state business with a regional office and industrial facility located in the City of Des Moines, at 3525 Vandalia Road in the SE AgriBusiness Park Urban Renewal Area, and,

WHEREAS, on February 25, 2013, by Roll Call No. 13-0344, the City Council approved an Urban Renewal Agreement for the Sale of Real Estate (the "Agreement") with Helena whereby Helena agreed to purchase approximately 30 acres of adjoining land more specifically described below, from the City for the expansion of Helena's facilities, and to construct one or more buildings on the purchased property for industrial use containing at least 100,000 square feet in conformance with a City approved Conceptual Development Plan; and,

WHEREAS, on November 4, 2013, by Roll Call No. 13-1729, the City Council approved a Conceptual Development Plan for a 100,000 square foot expansion of Helena's existing warehouse building onto the land purchased from the City; and,

WHEREAS, the warehouse building and other improvements to the property purchased from the City were timely completed in substantial compliance with the Agreement and the approved Conceptual Development Plan; and,

WHEREAS, Helena Industries, Inc., has requested that the City issue a Certificate of Completion to memorialize the satisfaction of its construction obligations for the property described below.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council hereby finds and acknowledges that Helena Industries, Inc., has satisfied its obligations to complete the expansion of its industrial facility on the property more specifically described below, in substantial compliance with the Agreement as amended, and the approved Conceptual Development Plan. This resolution shall serve as the Certificate of Completion to be issued by the City pursuant to Section 2.6 of the Agreement for the improvements to be located on the property described below.
