## ACCEPTING PROPOSAL FROM MIDAMERICAN ENERGY COMPANY TO REMOVE AND REPLACE STREETLIGHTS AT THE INTERSECTION OF HUBBELL AVENUE AND E. BROADWAY AVENUE, NOT TO EXCEED \$96,222.87

WHEREAS, construction of the intersection of Hubbell Avenue and E. Broadway Avenue requires removal of old street lights and installation of new streets lights; and

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to remove old street lights and install new street lights; and

WHEREAS, compensation will be based on actual costs, not to exceed \$96,222.87.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

- 1. That the proposal from MidAmerican Energy Company to the City of Des Moines for removal and installation of street lighting for the Hubbell Avenue and E. Broadway Avenue Intersection Improvements, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.
- 2. That the Mayor is hereby authorized and directed to accept the proposal for and on behalf of the City of Des Moines, Iowa.
- 3. That the Engineering Department is authorized to administer the terms specified in the proposal.
- 4. That the Finance Director is authorized to make payment to MidAmerican Energy Company for actual costs upon receipt of an invoice acceptable to the Engineering Department.
