## ORDINANCE NO.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000 related to administrative hearings, as heretofore amended, by amending Section 102-126.07 to correct a scrivener's error.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000 related to administrative hearings, as heretofore

amended, is hereby amended by amending Section 102-126.07 to correct a scrivener's error, as

follows:

## Sec. 102-126.07. Administrative hearing.

- (a) A person to whom a notice of administrative penalty has been issued for violation of sections <u>102-3</u> <u>102-2</u>, 102-124 and/or 102-126 may request an administrative hearing for review of the finding that a violation occurred pursuant to and in conformance with chapter three of this code.
- (b) A request for hearing on a notice of administrative penalty shall be made in writing and filed with the city clerk within ten (10) calendar days of the date of issuance of the notice. Such request shall include the address of the violator and state the basis for the appeal.

Section 2. This ordinance shall be in full force and effect from and after its passage and

publication as provided by law.
