APPROVING EXCEPTION TO THE CITY'S REQUEST FOR PROPOSAL (RFP) PROCESS FOR GOOD CAUSE AND APPROVING PROFESSIONAL SERVICES AGREEMENT (PSA) WITH SNYDER & ASSOCIATES, INC. FOR DESIGN PHASE SERVICES FOR THE CLOSSES CREEK STORM SEWER IMPROVEMENTS PHASE 2A, 2B, 3, AND 11, NOT TO EXCEED \$916,161

WHEREAS, the City Engineer recommends that the procurement of professional services for the Closes Creek Storm Sewer Improvements Phase 2A, 2B, 3, and 11, be exempted from the requirements of the Engineering Department's Request for Proposal (RFP) process and advertising requirement for good cause shown, pursuant to Section 2-726(b)(1)(a) of the Municipal Code of the City of Des Moines.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That good cause has been shown to exempt the procurement of the above described services from the requirements of the Engineering Department's RFP process and the advertising requirement of such Section.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the Professional Services Agreement between the City of Des Moines and Snyder & Associates, Inc., for a total cost not to exceed \$916,161, based on hourly rates, to provide professional services for Closes Creek Storm Sewer Improvements Phase 2A, 2B, 3, and 11, a copy of which is on file in the office of the City Clerk, is hereby approved as to form and content.

BE IT FURTHER RESOLVED: That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Professional Services Agreement for and on behalf of the City of Des Moines, Iowa.
