

ORDINANCE NO.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Section 114-658, relating to rates for city parking garages.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by

amending Section 114-658, relating to rates for city parking garages, as follows:

Sec. 114-658. Rates for City Parking Garages.

(a) Subject to section 114-666 of this subchapter, the following rates shall be charged at city parking garages.

- (b) For purposes of any outstanding parking license agreement for parking in a city parking garage, this section shall be deemed the successor code section to amended or repealed code sections 114-658, 114-659, 114-662, 114-663, 114-664, 114-665 and 114-665.05.

Section 2. This ordinance shall be in full force and effect on January 1, 2020.
