AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Section 114-658, relating to rates for city parking garages.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Section 114-658, relating to rates for city parking garages, as follows:

Sec. 114-658. Rates for City Parking Garages.

(a) Subject to section 114-666 of this subchapter, the following rates shall be charged at city parking garages.

Section 2. This ordinance shall be in full force and effect on January 1, 2020.
