RESOLUTION APPROVING SPONSORSHIP OF AN APPLICATION FOR FINANCIAL ASSISTANCE TO THE IOWA ECONOMIC DEVELOPMENT AUTHORITY (IEDA) UNDER THE HIGH QUALITY JOBS PROGRAM FOR FIDELITY & GUARANTY

WHEREAS, Fidelity & Guaranty Life Business Services, Inc. and Fidelity & Guaranty Life Insurance Company, Two Ruan Center, 601 Locust Street, Suite 1400, Des Moines, IA 50309, Karen Krug, Vice President, Human Resources (collectively, "Fidelity & Guaranty"), proposes to move and expand its operations and lease space in 801 Grand and has requested City support for its application to the Iowa Economic Development Authority (IEDA) for state tax incentives under IEDA's High Quality Jobs Program; and,

WHEREAS, the application requires the submission of a resolution in support of the project by the community in which the project will be located, which requirement is intended to be satisfied by this Roll Call and resolution; and,

WHEREAS, in exchange for creating 60 additional jobs, Fidelity & Guaranty may be eligible for \$155,563 in investment tax credit and \$71,915 in sales, service, & use tax refund; and,

WHEREAS, the High Quality Jobs Program requires that the City SUPPORT the application by Fidelity & Guaranty, enter into an agreement with IEDA, and provide a local community match in the form of a parking agreement providing 75 parking stalls at a 20% discount.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The City Council of the City of Des Moines expresses its support for the application to and an agreement with the IEDA, conditioned on Fidelity & Guaranty filing It supplication for assistance under the High Quality Jobs Program for the creation of 60 additional jobs with terms as outlined in this Resolution and the Council Communication.
- 2. The Mayor and the City Manager are hereby authorized and directed to sign any forms required by the Administrative Rules of the IEDA to evidence the City's support the application and agreement, upon approval by the City Legal Department.
