## APPROVAL OF PAYMENT OF \$50,000 TO CATCH DES MOINES FOR A SPONSORSHIP OF THE 2020 70.3 NORTH AMERICAN IRONMAN CHAMPIONSHIP AND IRONMAN EVENTS IN 2021 AND 2022

WHEREAS, the 70.3 North American Ironman Championship to be hosted in Des Moines will contribute greatly to the economic vitality and quality of life in Central Iowa; and

WHEREAS, athletes from all over the country will travel to Des Moines to compete in the Ironman 70.3 North American Championship and the event is expected to bring thousands of visitors into the City of Des Moines, with the 2020 event estimated to have an economic impact of \$10,000,000; and

WHEREAS, the supporting entity, Ironman Foundation, has provided over \$50,000,000 in charitable giveback since 2003 and has supported 8,300 organizations to date; and

WHEREAS, the Greater Des Moines Convention and Visitors Bureau, Inc. a/k/a Catch Des Moines offers sponsorships in order to hold this premier event; and

WHEREAS, the City of Des Moines and area businesses and charities would benefit from the 2020 70.3 North American Ironman Championship and the Ironman events to be held in subsequent years; and

WHEREAS, sponsorship of the 70.3 North American Ironman Championship and future Ironman events will further the public purposes to provide a positive economic impact on the City by enhancing the quality of life within the City and to promote economic growth.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the Council determines that the residents of the City of Des Moines will receive economic and well-being benefits from the 2020 70.3 North American Ironman Championship and from the Ironman events to be held in subsequent years and the City's sponsorship of such events will support such events.


