## APPROVING SALE OF MEMORIAL PLAQUES FOR PLACEMENT ON THE CHRIS AND MARCIE COLEMAN MULTI-USE RECREATIONAL TRAIL BRIDGE TO RAISE FUNDS FOR PARKS AND RECREATION DEPARTMENT YOUTH SPORTS SCHOLARSHIP PROGRAM

WHEREAS, on December 16, 2019, by Roll Call No. 19-1971, the City Council approved naming the new multi-use recreational trail bridge connecting Gray's Lake Park to the Gray's Station development over the Raccoon River as the Chris and Marcie Coleman Bridge; and

WHEREAS, the Parks and Recreation Department wishes to offer and sell memorial plaques for placement on the Chris and Marcie Coleman Bridge, which plaques would be identical to those on the Kruidenier Trail Bridge in Gray's Lake Park; and

WHEREAS, such memorial plaques would be sold for \$200 with revenues from the sale of such plaques, after deduction for the costs for manufacture and installation of the plaques, to be placed in a special revenue account managed by the Finance Director; and

WHEREAS, funds from such special revenue account will be used by the Parks and Recreation Department to subsidize scholarships for income eligible participants in the Parks and Recreation Department's Youth Athletic programming, with the current years' net revenues transferred to the General Fund prior to the end of each Fiscal Year.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the sale of memorial plaques for placement on the Chris and Marcie Coleman Bridge with such net revenues to be used to subsidize the Parks and Recreation Department's Youth Athletic program, as described above, is hereby approved.
