APPROVAL OF CONTRACT AND BOND AND PERMISSION TO SUBLET ON E. 30TH STREET BRIDGE REHABILITATION OVER U.P.R.R. \$8,168,859.12

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the contract and bond, in the amount of \$8,168,859.12, executed by Cramer and Associates, Inc., Robert Cramer, President/CAO, 3100 S.W. Brookside Drive, Grimes, IA, 50111 dated January 13, 2020, for the construction of the following improvement:

E. 30th Street Bridge Rehabilitation over U.P.R.R., 12-2016-001 BHM-SWAP-1945(828)--SA-77, STBG-SWAP-1945(833)--SG-77

The improvement includes the structural rehabilitation of the viaduct, consisting of the following: complete removal and replacement of the concrete bridge deck, replacement of all concrete barrier rails and sidewalk fencing, new bridge joints, structural modifications to bridge abutments, replacement of bridge bearings, rehabilitation of bridge piers, new drainage system, full blast cleaning and repainting of bridge beams, removal and replacement of approach pavement and sidewalks, new guardrail, repairs to retaining walls, traffic control, pavement markings, and other incidental items; all in accordance with the contract documents, including Plan File Nos. 597-116/223, located on E. 30th Street between Dean Avenue and Raccoon Street in Des Moines, Iowa

the same to be performed in accordance with the plans and specifications which have been heretofore approved by this Council, be and the same are hereby approved, subject to receipt of the contract and bond approved as to form by the Legal Department, and certificate of insurance acceptable to the Engineering Department. The attached "Contractor's Anticipated DBE/TSB Utilization" shows the Contractor's efforts to solicit DBE/TSB Participation in accordance with the Disadvantaged Business Enterprise/Targeted Small Business (DBE/TSB) Program.

BE IT FURTHER RESOLVED: That the City Manager or his or her designee be and is hereby authorized and directed to execute said contract on behalf of the City of Des Moines, subject to receipt of the contract and bond approved as to form by the Legal Department, and certificate of insurance acceptable to the Engineering Department. No contract shall be deemed to exist between the City of Des Moines and said Bidder until said contract has been executed by the Bidder, and shall have been approved by this Council and executed by the City Manager or his or her designee.
