APPROVAL OF SUBORDINATION AGREEMENT FOR MORTGAGE SECURING REHABILITATION OF PROPERTY AT 1345 7th STREET UNDER THE BLIGHTED PROPERTY REHABILITATION PROGRAM

WHEREAS, on January 8, 2018, by Roll Call No. 18-0075, the City Council approved the Blighted Property Rehabilitation (BPR) Program and Program Policy to provide financial assistance to investors, non-profit organizations, and other qualified developers for projects involving the acquisition, demolition and/or rehabilitation of vacant, abandoned and/or blighted residential properties in the City of Des Moines, and directed the Community Development Department to administer the Program; and

WHEREAS, on December 4, 2018, the City of Des Moines approved a Development Agreement ("Agreement") with Indigo Dawn, L.L.C. ("Developer") under the Blighted Property Rehabilitation program, whereby Indigo Dawn, L.L.C., agreed to undertake rehabilitation of a property at 1345 7th Street, Des Moines, Iowa, ("Property"), in consideration for which the City provided to Indigo Dawn, L.L.C., a forgivable loan in the amount of not more than \$35,000.00, which loan was secured by a mortgage on the Property, whose legal description is

LOT 22, GRAND PARK, AN OFFICIAL PLAT, NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.

all based on terms and conditions outlined in the Agreement;

WHEREAS, the City's mortgage herein was recorded on January 8, 2019, in Book 17205 at Page 612, of the office of Polk County Recorder; and

WHEREAS, on December 9, 2019, the City of Des Moines approved Amendment and Assignment of said Agreement transferring all rights, obligations, and interests from Indigo Dawn, L.L.C. to Astilbe Morning, L.L.C. ("Assignee") as authorized under both the BPR Program Policy and Agreement; and

WHEREAS, the Assignee and its lender, GreenState Credit Union, have requested that the City subordinate the City's mortgage recorded on January 8, 2019, in Book 17205 at Page 612, of the office of Polk County Recorder, pursuant to the Subordination Agreement in form on file with the Community Development Department; and

WHEREAS, the City of Des Moines is willing to subordinate its mortgage to induce GreenState Credit Union to provide such new financing, having determined that it is in the City's interest to facilitate this refinancing, and that the subordination will be without material impact on the
