

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2639, 114-2876, 114-3037, 114-3468, 114-3751 and 114-3766, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2639, 114-2876, 114-3037, 114-3468, 114-3751 and 114-3766, relating to traffic and vehicle regulations, as follows:

Sec. 114-2639. Sixth Avenue--Cherry Street to Mulberry Street.

~~_____ Sixth Avenue, on the west side, from Cherry Street to a point 150 feet north thereof, no parking any time.~~

Sixth Avenue, on the west side, from Cherry Street to a point 20 feet north thereof, no parking any time.

Sixth Avenue, on the west side, from a point 20 feet north of Cherry Street to a point 125 feet north thereof, official marked police vehicles only, Monday through Friday, 7:00 a.m. to 5:00 p.m.

Sec. 114-2876. East Thirty-second Street--East Court Avenue to East Aurora Avenue.

East Thirty-second Street, on the east side, from East Court Avenue to Dean Avenue, no parking any time.

East Thirty-second Street, on the west side, from East University Avenue to East Washington Avenue, no parking any time.

East Thirty-second Street, on the east side, from East University Avenue to a point 50 feet north thereof, no parking any time.


