## RESOLUTION REGARDING ALLOCATION OF HOME INVESTMENT PARTNERSHIP PROGRAM (HOME) FUNDS TO GREATER DES MOINES HABITAT FOR HUMANITY (HABITAT) FOR DEVELOPMENT OF AFFORDABLE HOUSING

**WHEREAS,** on November 4, 2019, by Roll Call No. 19-1792, the City Council approved the 2020-2024 Consolidated Plan, which includes the 2020 Action Plan, for the U.S. Department of Housing and Urban Development (HUD);

**WHEREAS**, the 2020-2024 Consolidated Plan includes the use of Home Investment Partnership Program (HOME) funding for affordable housing development; and

**WHEREAS**, in December 2019 Habitat submitted a proposal to city staff outlining a five-year schedule for HOME funding for construction of at least 10 HOME units, which will be sold to low-income homebuyers, each program year between 2020 and 2024; and

WHEREAS, staff has evaluated the developer's capacity and history with HOME funds, and once site addresses are known, each project site will be further underwritten—which includes review of the construction schedule, budget, site plans, construction drawings, environmental characteristics, and any other documentation used to review the project's risk; and

**WHEREAS**, the City Council annually committed at least \$250,000 to Habitat in the last Consolidated Planning cycle; and

**WHEREAS**, the City Manager and community development staff recommend that a portion of the City's anticipated future HOME funding be allocated to Habitat accordingly, dependent on the allocation of HOME funds to the City of Des Moines by HUD and completion of all the federal requirements in 24 CFR 92:
