RECEIVE AND FILE COMMUNICATION FROM THE ROOSEVELT CULTURAL DISTRICT SSMID BOARD REGARDING THE LEVY FOR THE ROOSEVELT CULTURAL DISTRICT SELF-SUPPORTED MUNICIPAL IMPROVEMENT DISTRICT

WHEREAS, the Roosevelt Cultural District Self-Supported Municipal Improvement District (the "Roosevelt Cultural District SSMID") was created by Ordinance No. 15,507 passed September 26, 2016; and,

WHEREAS, the Roosevelt Cultural District (the "RCD"), is an Iowa non-profit corporation which seeks to advance, promote and market the cultural, commercial and economic development of the Roosevelt commercial area; and,

WHEREAS, on August 20, 2018, by Roll Call No. 18-1416, the City Council approved an agreement with RCD whereby the RCD agreed to establish and administer the Roosevelt Cultural District SSMID Board to assist in the operation of the Roosevelt Cultural District SSMID; and,

WHEREAS, the duties of the Roosevelt Cultural District SSMID Board include reviewing the proposed Roosevelt Cultural District SSMID budget and levy for the next fiscal year and providing comments and a recommendation to the City Council; and,

WHEREAS, the Roosevelt Cultural District SSMID Board has recommended approval of the proposed Roosevelt Cultural District SSMID levy of \$1.75 per \$1,000 for the fiscal year ending June 30, 2021, as set forth in the accompanying memorandum.

RE: FY21 Roosevelt Cultural District SSMID

Roosevelt Cultural District Self Supported Municipal Improvement District (SSMID) has an active SSMID board that has reviewed and discussed their budget for the coming year. Below is a summary of the Roosevelt Cultural District SSMID for the FY21 budget year.

- Taxable Valuation for the District is \$3,298,801
- SSMID levy rate for the District is \$1.75/\$1,000 of taxable valuation
- Estimated revenue for PY21 is \$6,836 (including State Replacement Credit)
- Anticipated expenditures for FY21 is \$5,930
- Current Fund Balance is \$5,633

The Roosevelt Cultural District SSMID board recommends continuation of the SSMID levy at the current rate of \$1.75 per \$1,000 valuation for the FY21 budget year. The Roosevelt Cultural District SSMID will continue to provide for the maintenance of the streetscape improvements in the district.
