AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2126.01, 114-2651, 114-2804, 114-2947.05, 114-3033.0005, 114-3033.0006, 114-3033.0007, 114-3033.05, 114-3033.09, 114-3639, 114-3669, 114-3756 and by adding Section 114-2152.03, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2126.01, 114-2651, 114-2804, 114-2947.05, 114-3033.0005, 114-3033.0006, 114-3033.0007, 114-3033.05, 114-3033.09, 114-3639, 114-3669, 114-3756 and by adding Section 114-2152.03, relating to traffic and vehicle regulations, as follows:

Sec. 114-2126.01. East Fifty-sixth Street.

~~East Fifty-sixth Street, from East Oakhill Drive to East Douglas Avenue, stop.~~
East Fifty-sixth Street, from ~~East Douglas Avenue~~ the south city limits to the north city limits, stop.

Sec. 114-2152.03. Brook Ridge Court.

Brook Ridge Court, at Brook View Drive/Brook View Avenue, stop.

Sec. 114-2651. Sixth Avenue--Euclid Avenue to Aurora Avenue.

Sixth Avenue, on the east side, from Euclid Avenue to a point 100 feet north thereof, no parking any time.

Sixth Avenue, on the east side, from a point 100 feet north of Euclid Avenue to a point 60 feet south of Clinton Avenue, two-hour parking 9:00 a.m. to 4:00 p.m.

Sixth Avenue, on the east side, from a point ~~200~~ 235 feet south of Douglas Avenue to a point ~~30~~ 25 feet ~~south~~ north thereof, commercial loading zone.

Sixth Avenue, on the west side, from a point ~~100-90~~ feet north of Euclid Avenue to a point 42 feet north thereof, commercial loading zone.

~~Sixth Avenue, on the west side, from a point 100 feet north of Euclid Avenue to a point 42 feet north thereof, no parking 4:00 p.m. to 6:00 p.m.~~

Sixth Avenue, on the west side, from a point 70 feet south of Douglas Avenue to a point 20 feet north thereof, commercial loading zone.

Sixth Avenue, on the west side, from a point ~~142-132~~ feet north of Euclid Avenue to a point 70 feet south of Douglas Avenue, two-hour parking 9:00 a.m. to 4:00 p.m.

Sixth Avenue, on the west side, from a point 50 feet south of Douglas Avenue to a point 75 feet north of Douglas Avenue, no parking any time.

East Twenty-first Street, on the east side, from East Grand Avenue to a point 50 feet north thereof, no parking any time.

East Twenty-first Street, on the east side, from East Grand Avenue to Des Moines Street, no parking any time.

East Twenty-first Street, on the west side, from East Walnut Street to East Grand Avenue, no parking any time.

East Twenty-first Street, on the east side, from Lyon Street to Maple Street, no parking any time.

Sec. 114-2947.05. East fifty-fourth Court—Dead end south of Brook View Avenue to East Douglas Avenue to dead end.

East Fifty-fourth Court, on the west side, from the dead end south of Brook View Avenue to East Douglas Avenue to the dead end, no parking any time.

Sec. 114-3033.0005. Brook Landing Circle—Cul-de-sac north of Brook Landing Drive to East Fifty-fourth Court to dead end.

Brook Landing Circle, on the west and south sides, from and including the cul-de-sac north of Brook Landing Drive to East Fifty-fourth Court to the dead end, no parking any time.

Sec. 114-3033.0006. Brook Landing Court—East Fifty-sixth Street to Brook View Avenue to east city limits.

Brook Landing Court, on the south and -west sides, from East Fifty-sixth Street to Brook View Avenue to the dead end south of Village Run Avenue, no parking any time.

Sec. 114-3033.0007. Brook Landing Drive—East Fifth-fourth Court to Brook Landing Circle to East Fifty-fourth Court.

Sec. 114-3756. East Washington Avenue--Dead end west of Pennsylvania Avenue to the dead end of East Thirty-third Street.

East Washington Avenue, on the north side, from East Ninth Street to a point 75 feet west thereof, no parking any time.

East Washington Avenue, on the north side, from Pennsylvania Avenue to a point 430 feet west thereof, and any part of the cul-de-sac, no parking any time.

East Washington Avenue, on the south side, from Pennsylvania Avenue to a point 150 feet east of East Fourteenth Street, no parking any time.

East Washington Avenue, on the north side, from East Fourteenth Street to a point 75 feet west thereof, no parking any time.

East Washington Avenue, on the north side, from East Fourteenth Street to East Seventeenth Court, no parking any time.

East Washington Avenue, on the south side, from Sampson Street to East Seventeenth Street, no parking any time.


East Washington Avenue, on the north side, from East Thirty-second Court to a point 50 feet west thereof, no parking any time.
