APPROVING AND ADOPTING A SCHEDULE OF ADMINISTRATIVE PENALTIES FOR PUBLIC NUISANCE DEPOSITING DIRT, DEBRIS OR OTHER MATERIAL ON PUBLIC PROPERTY AND FOR DISCHARGE OF WATER ON SIDEWALKS, STREETS, AND REAL PROPERTY IN VIOLATION OF CHAPTER 42 AS AUTHORIZED BY THE MUNICIPAL CODE OF THE CITY OF DES MOINES

WHEREAS, Sections 42-348(25) and 42-348(26) of the Municipal Code identify as a public nuisance depositing dirt, debris, or other material on public real property and discharge of waters collected upon private real property from subsurface or surface drainage on a sidewalk, street or adjoining real property causing or threatening to cause damage to anything of value on such real estate on sidewalks, respectively, and Section 42-362 provides for the giving of an administrative notice of violation and assessment of an administrative penalty for violation of sections 42-348(25) and 42-348(26) of the Municipal Code, the amounts of which administrative penalties are to be set in a Schedule of Administrative Penalties adopted by the City Council by resolution; and

WHEREAS, a Schedule of Administrative Penalties has been prepared for Council consideration and is recommended for adoption, which Schedule of Administrative Penalties is appended hereto and is now on file in the Office of the City Clerk.

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA that the Schedule of Fees appended hereto and by this reference hereto is hereby approved and adopted.

BE IT FURTHER RESOLVED that said Schedule of Administrative Penalties shall be maintained on file in the office of the City Clerk and the Public Works Department for public reference, and that the fees therein established shall become effective upon and as of April 21, 2020.
