APPROVAL OF CERTIFICATION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT OF THE AMENDED OPERATING BUDGET FOR ALL PROJECTS FOR FISCAL YEAR ENDING JUNE 30, 2020 AND OF THE PROPOSED OPERATING BUDGET FOR ALL PROJECTS FOR FISCAL YEAR ENDING JUNE 30, 2021

WHEREAS, on March 9, 2020, by Roll Call Nos. 20-0390 and 20-0391, the Municipal Housing Governing Board set the public hearings to consider the Municipal Housing Agency’s amended annual budget for all projects for the current fiscal year ending June 30, 2020 and to consider the Municipal Housing Agency’s proposed budget for all projects for the fiscal year ending June 30, 2021, for March 23, 2020 and public notice of such hearings was published as provided by law and pursuant to a state of emergency due to the spread of the COVID-19 virus the Municipal Housing Governing Board by Roll Call Nos. 20-0493 and 20-0494 continued the public hearing to April 27, 2020 ; and

WHEREAS, following the respective public hearings on April 27, 2020, the Municipal Housing Governing Board approved the Municipal Housing Agency’s amendment to annual budget for all projects for the current fiscal year ending June 30, 2020, by Roll Call No. 20-_____ and approved the Municipal Housing Agency’s proposed budget for all projects for the fiscal year ending June 30, 2021 by Roll Call No. 20-_____ ; and

WHEREAS, the Des Moines Municipal Housing Agency is required to certify approval of the operating budgets to the U.S. Department of Housing and Urban Development.

NOW, THEREFORE, BE IT RESOLVED by the Municipal Housing Governing Board that the Mayor and City Clerk, as appropriate, are hereby authorized and directed to certify the Municipal Housing Agency’s amended annual budget for all projects for the fiscal year ending June 30, 2020 and to certify the Municipal Housing Agency’s proposed budget for all projects for the fiscal year ending June 30, 2021 on the forms on file in the Office of the City Clerk and the Community Development Director is hereby directed to submit such certifications to the U.S. Department of Housing and Urban Development.
