**ACCEPTING PROPOSAL OF TYLER TECHNOLOGIES, INC. TO PROVIDE RECORDS MANAGEMENT SOLUTIONS FOR POLICE DEPARTMENT AND AUTHORIZING CITY MANAGER TO NEGOTIATE AN AGREEMENT FOR THE PROVISION OF SAME**

WHEREAS, on September 18, 2019, a Request for Proposals (RFP) for the acquisition of a Record Management System and Jail Management System solution for the City of Des Moines Police Department and Polk County Sheriff's Office, RFP N20-01, was issued by the Procurement Division of the Finance Department; and

WHEREAS, the Procurement Administrator solicited proposals by advertising and mailing of RFP N20-01 and four RMS proposals were received; and

WHEREAS, an Evaluation and Selection Committee has reviewed and evaluated the proposals and has recommended that an agreement be awarded to Tyler Technologies, Inc., Lynn Moore, Jr., CEO, 840 West Long Road, Troy MI 48098, to provide record management software and implementation services; and

WHEREAS, the City Manager desires to negotiate an agreement with Tyler Technologies, Inc. for the software and services with a total estimated initial cost of \$1,270,255, depending on final option selected, with the cost to be shared with Polk County on an approximate two-thirds to one-third basis, and with proposed annual maintenance costs beginning in year 2 in the amount of \$102,901, with annual maintenance fees thereafter subject to a limited rate increase for the next 5 years.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the proposal for Record Management System submitted by Tyler Technologies, Inc. is hereby accepted and approved and the City Manager is hereby authorized to negotiate an agreement with Tyler Technologies, Inc., as described above and to submit such proposed agreement to the City Council for approval.
