**ACCEPTANCE OF PROPOSAL FROM MIDAMERICAN ENERGY COMPANY
TO INSTALL STREET LIGHTING AND PEDESTRIAN LIGHTING FOR
INGERSOLL AVENUE STREETScape PHASE 1,
NOT TO EXCEED \$72,565.45**

WHEREAS, construction of Ingersoll Avenue Streetscape Phase 1 requires installation of new streets lighting and pedestrian lighting; and

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to install eight (8) new banner-strength, black street light poles with LED street lighting and LED pedestrian lighting for Ingersoll Avenue Streetscape Phase 1; and

WHEREAS, compensation will be based on actual costs, not to exceed \$72,565.45.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the proposal from MidAmerican Energy Company to the City of Des Moines for installation of street lighting for Ingersoll Avenue Streetscape Phase 1, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.
2. That the Mayor is hereby authorized and directed to accept the proposal for and on behalf of the City of Des Moines, Iowa.
3. That the Engineering Department is authorized to administer the terms specified in the proposal.
4. That the Finance Director is authorized to make payment to MidAmerican Energy Company for actual costs upon receipt of an invoice acceptable to the Engineering Department.
