AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Chapter 114, by amending Sections 114-1990, 114-2614, 114-2691, 114-2692, 114-2693, 114-2695, 114-3135, 114-3582, and 114-3781, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Chapter 114, by

amending Sections 114-1990, 114-2614, 114-2691, 114-2692, 114-2693, 114-2695, 114-3135,

114-3582, and 114-3781, relating to traffic and vehicle regulations, as follows:

### Sec. 114-1990. Southwest First Street.

Southwest First Street, at Edison Avenue, stop.

Southwest First Street, at Hillside Avenue, stop.

#### Sec. 114-2614. Southwest Third Street--Vine Street to Army Post Road.

Southwest Third Street, on the west side, from Vine Street to a point 15 feet south thereof, no parking any time.

Southwest Third Street, on the west side, from a point 80 feet south of Vine Street to vacated Market Street, no parking any time.

Southwest Third Street, on the east side, from Market Street to a point 32 feet north, no parking any time.
