WHEREAS, the Information Technology (IT) Department has requested the Finance Department's Procurement Division issue a purchase order for approval of the purchase of server virtualization VMware vSphere Upgrade licensing and 3 years of software support from OneNeck IT Solutions for a total amount of \$63,467.22; and

WHEREAS, the Information Technology Department needs to upgrade its VMware virtualization software edition due to the end of sale of the current edition by the vendor; and

WHEREAS, this purchase is being procured through the competitive bid process using the National Association of State Procurement Officers (NASPO) Contract MNNVP-134, Iowa State Addendum #16054C; and

WHEREAS, Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the purchase of server virtualization VMware vSphere Upgrade licensing and 3 years of software support for the Information Technology (IT) Department is being purchased from OneNeck IT Solutions, 8401 Greenway Boulevard, Middleton, WI 53562, Terry Swanson (President and Chief Executive Officer); and

WHEREAS, funding is available in CIP FY2020/21-2025/26, MS001, C051IT99, Miscellaneous Improvements Enhanced City-wide Information and Communication Systems, page 7.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of server virtualization VMware vSphere Upgrade licensing and 3 years of software support from OneNeck IT Solutions in the total amount of \$63,467.22 using National Association of State Procurement Officers (NASPO) Contract MNNVP-134, Iowa State Addendum #16054C.
