**APPROVAL OF LETTER OF SUPPORT FOR DES MUNICIPAL HOUSING AGENCY'S DISPOSITION APPLICATION**

**WHEREAS**, the Des Moines Municipal Housing Agency (DMMHA) administers Public Housing, which is funded by the U.S. Department of Housing & Urban Development (HUD); and

**WHEREAS**, the DMMHA owns and operates 34 scattered site single-family units as a part of the Public Housing program; and

**WHEREAS**, the DMMHA has determined that these properties are unsustainable to continue to operate as units in our Public Housing program; and

**WHEREAS**, the DMMHA recommends disposing of the following sixteen (16) units at this time: 314 Indiana, 1655 Garfield, 1248 McCormick, 1246 E 17<sup>th</sup> Street, 1827 Allison Avenue, 3026 Hubbell Avenue, 2403 Payne Road, 1219 15<sup>th</sup> Place, 1615 SE Glenwood Drive, 2600 E 39<sup>th</sup> Court, 1604 23<sup>rd</sup> Street, 1428 E 15<sup>th</sup> Street, 1373 Idaho Street, 1624 Lincoln Avenue, 1423 17<sup>th</sup> Street, and 1432 62<sup>nd</sup> Street.

**WHEREAS**, the Disposition Application to HUD requires a letter of support from the local government.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, as follows:

1. The City of Des Moines supports the DMMHA's Disposition Application that includes sixteen (16) scattered site Public Housing units.
2. The Mayor is hereby directed to sign the attached letter of support on behalf of the City of Des Moines.
3. The Neighborhood Services Director is directed to submit the letter on behalf of the City.


