RESOLUTION AUTHORIZING THE REDEMPTION OF  
OUTSTANDING GENERAL OBLIGATION REFUNDING  
BONDS, SERIES 2013B, OF THE CITY OF DES MOINES,  
STATE OF IOWA, DATED AUGUST 28, 2013, AND  
DIRECTING NOTICE BE GIVEN

WHEREAS, the City did by resolution dated August 12, 2013, authorize the issuance of \$21,050,000 General Obligation Refunding Bonds, Series 2013B, (the "Bonds") dated August 28, 2013; and

WHEREAS, the Bonds are redeemable in any order of their numbering on June 1, 2021 or any date thereafter upon giving notice in the manner provided in the resolution authorizing the issuance of the Bonds; and

WHEREAS, it is deemed necessary and advisable that \$10,060,000 be so redeemed on June 1, 2021 and notice of redemption be given according to the terms of the resolution authorizing issuance of the Bonds.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, STATE OF IOWA:

Section 1. That outstanding General Obligation Refunding Bonds, dated August 28, 2013, in the principal amount of \$10,060,000, be and the same are hereby redeemed as of June 1, 2021.

Section 2. The Registrar and Paying Agent, City Treasurer, is hereby authorized and directed to cause notice of such redemption be given not less than thirty (30) days prior to the redemption date and to cause notice of redemption to be mailed to the registered owners of the Bonds by ordinary mail, and to notify DTC.

Section 3. The Finance Director is hereby authorized and directed to cause to be deposited in a separate fund sum sufficient to pay all principal and interest on the redeemed Bonds to the date of redemption and to notify the City's dissemination agent to post the Notice of Redemption to the MSRB's website (EMMA) in searchable PDF format for the refunded Bonds in accordance with the Continuing Disclosure Certificate for the Bonds.
