## APPROVAL OF DONATION AND NAMING AGREEMENT WITH SUSAN MOORE AND DES MOINES PARK & RECREATION FOUNDATION FOR NATURAL PLAYSCAPE AT MACRAE PARK AND NAMING THE PLAYSCAPE THE "LARRY E. MOORE NATURAL PLAYSCAPE AT MACRAE PARK"

WHEREAS, the City of Des Moines, acting through the Parks and Recreation Department, operates MacRae Park; and

WHEREAS, Susan Moore desires to participate with the City to support improvements to MacRae Park by making a charitable donation in the amount of \$300,000, towards the construction of a natural playscape in MacRae Park, as a gift to the citizens of Des Moines; and

WHEREAS, Susan Moore desires to provide such donation to the Friends of Des Moines Parks as reimbursement to the City upon completion of the natural playscape improvements; and

WHEREAS, the Parks and Recreation Department staff developed a plan for a new natural playscape feature at MacRae Park at an estimated cost of \$500,000 with construction anticipated to begin in Spring 2021 and completed by Fall 2022; and

WHEREAS, a Donation Agreement between the City of Des Moines and Susan Moore and the Friends of Des Moines Parks, which is on file in the City Clerk's office, provides for the Friends to make such charitable donation to the City for the natural playscape; and

WHEREAS, such agreement provides that the natural playscape will be named the "Larry E. Moore Natural Playscape at MacRae Park"; and

WHEREAS, in order to expedite such naming, the City Council desires to waive the requirements of the City's Policy for Naming of Streets, Facilities and Park Land for the naming of such playscape in honor of Larry E. Moore and to acknowledge such a generous donation.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the agreement with Susan Moore and the Des Moines Park & Recreation Foundation for the donation of \$300,000 towards the construction of a natural playscape at MacRae Park, a copy of which is available in the City Clerk's Office, is hereby approved and the Mayor is authorized and directed to sign the Donation Agreement on behalf of the City and the City Clerk is authorized and directed to attest to his signature.

BE IT FURTHER RESOLVED that, upon its completion, the natural playscape shall b and is hereby named and to be known as the "Larry E. Moore Natural Playscape at MacRae Park" for a period of twenty years.
