ORDINANCE NO. _____

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2864, 114-3039, 114-3512, 114-3672, and 114-3762, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2864, 114-3039, 114-3512, 114-3672, and 114-3762, relating to traffic and vehicle regulations, as follows:

Sec. 114-2864. Southeast Thirtieth Street--East Court Avenue to Hart Avenue.

Southeast Thirtieth Street, on both sides, from East Court Avenue to Vandalia Road, no parking any time.

Southeast Thirtieth Street, on the west side, from Hartford Avenue to East Watrous Avenue, no parking any time.

Southeast Thirtieth Street, on the west side, from East Titus Avenue to Easter Lake Drive, no parking any time.

Southeast Thirtieth Street, on the east side, from East Titus Avenue to a point 80 feet south thereof, no parking any time.

Southeast Thirtieth Street, on the west side, from Easter Lake Drive to Hart Avenue, no parking any time.

Sec. 114-3039. Burlington Terrace--Chautauqua Parkway to Sixteenth Street.

Burlington Terrace, on the south side, from the east leg of Chautauqua Parkway to Sixteenth Street, no parking any time.

Burlington Terrace, on the north side, from the west leg of Chautauqua Parkway to Sixteenth Street, no parking any time.

Burlington Terrace, on the north side, from Nash Drive to a point 50 feet east thereof, no parking any time.

Sec. 114-3512. Mulberry Street--Thirteenth Street to Fifteenth Street.

Mulberry Street, on the north side, from Thirteenth Street to 460 feet west thereof, no parking any time.

Mulberry Street, on the north side, from a point 20 feet east of Falcon Drive to Fifteenth Street, no parking any time.

Mulberry Street, on the north side, from a point 460 feet west of Thirteenth Street to a point 60 feet west thereof, loading zone.

Mulberry Street, on the south side, from Thirteenth Street to a point 300 feet west thereof, no parking any time.

Mulberry Street, on the south side, from a point 415 feet west of Thirteenth Street to a point 50 feet west thereof, loading zone.

Mulberry Street, on the south side, from a point 655 feet west of Thirteenth Street to a point 45 feet west thereof, no parking any time.

Mulberry Street, on the south side, from a point 825 feet west of Thirteenth Street to Fifteenth Street, no parking any time.

Sec. 114-3672. East Titus Avenue--South Union Street to Southeast Thirty-second Street.

East Titus Avenue, on the north side, from South Union Street to a point 50 feet east thereof, no parking any time.

East Titus Avenue, on the north side, from a point 315 feet east of South Union to a point 270 feet east thereof, no parking any time.

East Titus Avenue, on the south side, from South Union Street to Southeast Seventh Street, no parking any time.

East Titus Avenue, on the north side, from Indianola Avenue to Southeast Thirty-second Street, no parking any time.

East Titus Avenue, on the south side, from Southeast Thirtieth Street to a point 30 feet east thereof, no parking any time.

East Titus Avenue, on the south side, from a point 550 feet west of Southeast Thirty-second Street to a point 335 feet east thereof, no parking any time.

Sec. 114-3762. East Watrous Avenue--South Union Street to Hartford Avenue.

East Watrous Avenue, on the north side, from South Union Street to a point 50 feet east of Southeast Fourteenth Street, no parking any time.


East Watrous Avenue, on the south side, from Southeast Thirteenth Street to a point 50 feet east of Southeast Fourteenth Street, no parking any time.

East Watrous Avenue, on the north side, from Indianola Avenue to a point 180 feet west thereof, no parking any time.

East Watrous Avenue, on both sides, from Southeast Twenty-fourth Street to Hartford Avenue, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
