APPROVING EXTENSION OF CONTRACT FOR MUNICIPAL ADVISOR FOR FINANCIAL SERVICES WITH PFM FINANCIAL ADVISORS LLC

WHEREAS, by Roll Call 16-0048 of January 11, 2016 the City Council approved a Contract for Municipal Advisor for Financial Services with Public Financial Management, Inc. ("Agreement") which Agreement authorized municipal financial advisor services, with extensions, through June 30, 2021 and which Agreement was assigned with City consent to PFM Advisors LLC; and

WHEREAS, PFM Advisors LLC has agreed to an extension of municipal financial advisor services for the City and the City Manager has recommended good cause for exemption from the competitive procurement requirements and approving an extension of the Agreement to September 30, 2021 as set forth in the attached Council Communication; and



AGREEMENT FOR EXTENSION OF CONTRACT FOR MUNICIPAL ADVISOR FOR FINANCIAL SERVICES

WHEREAS, the City of Des Moines, Iowa (hereinafter called ("City") and Public Financial Management, Inc. entered into the Contract for Municipal Advisor for Financial Services dated January 11, 2016 ("Agreement") and said Agreement was assigned with City consent to PFM Financial Advisors LLC ("Municipal Advisor"); and

WHEREAS, the term of said Agreement with Municipal Advisor, as extended by options to extend the term of such Agreement exercised by the City, ends June 30, 2021; and

WHEREAS, the City and Municipal Advisor desire to extend the Agreement to the September 30, 2021.

NOW, THEREFORE, for and in consideration of the respective agreements, undertakings, and mutual covenants herein contained, the parties mutually agree as follows:

1. The term of the Contract for Municipal Advisor for Financial Services is hereby extended until September 30, 2021.

2. During such extended term, Assignee shall be compensated as set forth in Section II of the Agreement.

3. The parties hereto agree to abide by and be subject to all terms and conditions as set forth in the Agreement for such extended term.
