## HOLD HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF A PERMANENT UNDERGROUND ELECTRIC EASEMENT ON CITY-OWNED PROPERTY LOCATED SOUTH OF AND ADJOINING LINE DRIVE BETWEEN SOUTHWEST 2<sup>ND</sup> STREET AND SOUTHWEST 3<sup>RD</sup> STREET TO MIDAMERICAN ENERGY COMPANY FOR \$1

WHEREAS, MidAmerican Energy Company is required by the City of Des Moines to reroute a power feed that is in conflict with a City construction project at Line Drive between Southwest 2<sup>nd</sup> Street and Southwest 3<sup>rd</sup> Street; and

WHEREAS, MidAmerican Energy Company has requested an underground electric line easement across a portion of excess City-owned property located south of and adjoining Line Drive, described below (hereinafter "Property"), in order to accommodate the relocation of the power feed; and

WHEREAS, the City will not be inconvenienced by the conveyance of a Permanent Underground Electric Easement within the Property; and

**WHEREAS**, on May 24, 2021, by Roll Call No. 21-0781, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed conveyance of the Permanent Underground Electric Easement ("Easement") be set for hearing on June 14, 2021, at 5:00 p.m. in the City Council Chamber, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and

WHEREAS, due notice of said proposal to convey the Easement was given to all necessary parties as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.
