

ORDINANCE NO. _____

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-328.01, 114-2670, 114-2725, 114-2726, 114-3015, and 114-3423, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-328.01, 114-2670, 114-2725, 114-2726, 114-3015, and 114-3423, relating to traffic and vehicle regulations, as follows:

Sec. 114-328.01. Pedestrian Safety, Use of Medians.

....

(b) For streets with a speed limit of 30 miles per hour or higher, pedestrians are prohibited from standing, sitting or staying on a median for any purpose other than to cross the street unless the width of the top surface of the median, excluding the curbs is at least 6 feet wide. This prohibits pedestrians from standing, sitting or staying on a median at the following intersections in the city:

- University Ave and 6th Avenue
- W Martin Luther King, Jr Pkwy and Fleur Dr
- W Martin Luther King, Jr Pkwy and SW 16th St

- (c) Section 114-328.01(b) does not apply to:
- (1) Police officers, peace officers and parking enforcement personnel of the police department or employees of the fire department while performing official duties of the city.
 - (2) Employees or contactors for the city or other individuals authorized by the city to perform construction or maintenance work on city streets or rights-of-way, while performing construction or maintenance work on the street provided that proper street signage is used and streets are blocked off as required by the city.
 - (3) Any individual responding to an emergency in the street.

Sec. 114-2670. East Seventh Street--East Vine Street to East Aurora Avenue.

East Seventh Street, on the east side, from East Vine Street to East Court Avenue, no parking any time.

East Seventh Street, on the east side, from East Court Avenue to East Walnut Street, no parking any time.

East Seventh Street, on the west side, from a point 160 feet north of East Court Avenue to a point 40 feet north thereof, commercial loading zone.

East Seventh Street, on the west side, from East Walnut Street to a point 25 feet south thereof, no parking any time.

East Seventh Street, on the east side, from East Walnut Street to a point 20 feet north thereof, no parking any time.

East Seventh Street, on the west side, from Lyon Street to a point 340 feet north thereof, no parking any time.

East Seventh Street, on the east side, from Walker Street to a point 55 feet north thereof, no parking any time.

East Seventh Street, on the east side, from Buchanan Street to a point 50 feet south thereof, no parking any time.

East Seventh Street, on the west side, from Walker Street to Fremont Street, no parking any time.

East Seventh Street, on the east side, from a point 50 feet south of Fremont Street to Fremont Street, no parking any time.

East Seventh Street, on the east side, from Hull Avenue to a point 75 feet north thereof, no parking any time.

East Seventh Street, on the west side, from Hull Avenue to East Douglas Avenue, no parking any time.

East Seventh Street, on the east side, from East Euclid Avenue to a point 50 feet south thereof, no parking any time.

East Seventh Street, on the east side, from East Euclid Avenue to a point 50 feet north thereof, no parking any time.

East Seventh Street, on the west side, from East Shawnee Avenue to East Aurora Avenue, no parking any time.

Sec. 114-2725. Twelfth Street--Walnut Street to Locust Street.

Twelfth Street, on the east side, from Walnut Street to a point 30 feet north thereof, no parking any time.

Twelfth Street, on the east side, from a point 30 feet north of Walnut Street to Locust Street, no parking, standing or stopping from 9:00 p.m. until 6:00 a.m. on Friday, Saturday and Sunday.

Twelfth Street, on the west side, from Walnut Street to Locust Street, no parking any time.

Sec. 114-2726. Twelfth Street--Locust Street to Grand Avenue.

Twelfth Street, on the east side, from Grand Avenue to a point 45 feet south thereof, no parking any time.

Twelfth Street, on the east side, from a point 50 feet north of Locust Street to a point 45 feet south of Grand Avenue, no parking, standing or stopping from 9:00 p.m. to 6:00 a.m. on Friday, Saturday and Sunday.

Twelfth Street, on the east side, from Locust Street to a point 50 feet north thereof, no parking any time.

Twelfth Street, on the west side, from Grand Avenue to Locust Street, no parking any time.

Sec. 114-3015. East Bell Avenue--South Union Street to King Avenue.

East Bell Avenue, on both sides, from South Union Street to Indianola Avenue, no parking any time.

East Bell Avenue, on the south side, from Indianola Avenue to Southeast Fifth Street, no parking any time.

East Bell Avenue, on the south side, from Southeast Fifth Street to a point 50 feet east thereof, no parking any time.

East Bell Avenue, on the north side, from Southeast Fifth Street to and including the dead end east of Southeast Seventeenth Street, no parking any time.

East Bell Avenue, on the south side, from a point 50 feet west of Southeast Sixth Street to Southeast Seventh Street, no parking any time.

East Bell Avenue, on the south side, from Southeast Eighth Street to a point 150 feet east of Southeast Fourteenth Street, no parking any time.

East Bell Avenue, on the north side, from Southeast Nineteenth Street to King Avenue, no parking any time.

Sec. 114-3423. Locust Street--Fifth Avenue to Sixth Avenue.

Locust Street, on the south side, from Fifth Avenue to a point 100 feet west thereof, no parking any time.


Locust Street, on the south side, from a point 100 feet west of Fifth Avenue to a point 95 feet west thereof, commercial loading zone.

Locust Street, on the south side, from a point 195 feet west of Fifth Avenue to Sixth Avenue, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.

Locust Street, on the north side, from a point 60 feet west of Fifth Avenue to a point 85 feet west thereof, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
