

ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Section 114-3572, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Section 114-3572, relating to traffic and vehicle regulations, as follows:

**Sec. 114-3572. Pleasant Drive--Fifty-sixth Street to Sixty-third Street.**

Pleasant Drive, on the north side, from Fifty-sixth Street to a point 50 feet west thereof, no parking any time.

Pleasant Drive, on the south side, from Fifty-sixth Street to Sixty-third Street, no parking any time.

Pleasant Drive, on the north side, from Cummins Parkway to a point 370 feet east thereof, no parking any time.

Pleasant Drive, on the north side, from a point 235 feet west of Sixty-first Street to Sixty-second Street, no parking any time.

Pleasant Drive, on the north side, from Sixty-third Street to a point 75 feet east thereof, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.

Mayor and Council Representatives,

Our neighborhood has received notice of a proposal to extend the No Parking section on the north side of Pleasant by 130 feet. I oppose this for several reasons.

First, it appears that this decision is based on a single complainant that does not live on Pleasant Drive. The traffic on Pleasant between 56th and 63rd has increased significantly since the Grand Avenue bridge was repaired. Pleasant Drive is a residential street. It is not a primary or minor arterial or collector. Folks should not be commuting down Pleasant Drive, but we see daily commuting traffic as well as significant business and truck traffic. I think a decision to restrict our parking for someone who does not live on the street is unreasonable, especially since there is already No Parking on the south side of the street. This proposal, if enacted, would eliminate on-street parking for 8 houses for visitors, family, and business/service contractors.

Second, the original complaint mentions safety issues because of the significant curve at the bottom of the hill on Pleasant in the 5800 block. Those of us who live on Pleasant are aware of the curve but are also aware that at the posted speed with due caution vehicles can easily pass simultaneously on Pleasant even when cars are parked. Those who are having trouble with safe curve negotiation are, in my experience, travelling well above the posted speed limit.

Finally, our neighborhood has long been frustrated with the speed issues in this section of Pleasant Drive. The strategy in the rest of the city has been to utilize parking and parking patterns to slow/calm speed. If the city removes more parking from the north side of Pleasant, the concern is that the speed from westbound traffic on Pleasant will simply increase, creating greater overall safety concerns.

I have been informed that a traffic calming study will be done on this section of Pleasant Drive, but it will not begin until after the WB I-235 63rd Street exit is reopened, which is anticipated to take another 2-3 weeks. My request is that any modifications to the parking ordinances on Pleasant between Cummings Parkway and 56th be tabled until such time as the traffic study can be completed and the results examined.
