HOLD HEARING FOR APPROVAL OF DOCUMENTS TO CORRECT THE VACATION OF A PORTION OF COHEN PARK LOCATED NORTH OF AND ADJOINING 1106 SCOTT AVENUE AND TO ISSUE A CORRECTED QUIT CLAIM DEED TO DES MOINES CLIMATE CONTROLLED STORAGE, LLC

WHEREAS, on October 18, 2021, by Roll Call No. 21-1579, the City Council of the City of Des Moines voted to pass Ordinance No. 16,053 vacating a portion of Cohen Park located north of and adjoining 1106 Scott Avenue, Des Moines, Iowa and to approve the sale of such vacated parkland to Des Moines Climate Controlled Self Storage, LLC, subject to the reservation of easements for any existing utilities until such time that they are abandoned; and

WHEREAS, subsequent to passing Ordinance No. 16,053 and recording a quit claim deed conveying said vacated parkland, an error was discovered in the legal description of the vacated parkland leading to the need to repeal said ordinance, pass a new ordinance to vacate the properly described portion of Cohen Park, and issue a Corrected Quit Claim Deed; and

WHEREAS, on January 10, 2022, by Roll Call No. 22-0041, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed corrected vacation and conveyance be set for hearing on January 24, 2022, at 5:00 p.m., in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and

WHEREAS, due notice of said proposal to repeal Ordinance No. 16,053 and to correct the vacation and conveyance was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed corrected vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed repeal of Ordinance No. 16,053 and the vacation of the portion of Cohen Park as described herein, are hereby overruled and the hearing is closed.
2. There is no public need or benefit for the parkland proposed to be vacated, and the public would not be inconvenienced by reason of the vacation of a portion of Cohen Park lying north of and adjoining 1106 Scott Avenue, Des Moines, Iowa, legally described as follows, subject to the reservation of easements for any existing utilities until such time that they are abandoned, and said vacation is hereby approved:

4. The Mayor is authorized and directed to sign the Corrected Quit Claim Deed for the conveyance as identified above, and the City Clerk is authorized and directed to attest to the Mayor's signature.

The City Clerk is authorized and directed to forward the original of the Corrected Quit Claim Deed, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Real Estate Division of the Engineering Department for the purpose of causing said documents to be recorded.
6. The Real Estate Division Manager is authorized and directed to forward the original of the Corrected Quit Claim Deed, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Polk County Recorder's Office for the purpose of causing these documents to be recorded.
7. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the original of the Corrected Quit Claim Deed and a copy of the other documents to the grantee.
8. There are no proceeds associated with this action.
