**ACCEPTANCE OF A PROPOSAL FROM MIDAMERICAN ENERGY COMPANY
TO INSTALL NEW LED STREETLIGHTS FOR
GRAY'S PARKWAY EXTENSION,
ESTIMATED AT \$139,738.85**

WHEREAS, the extension of Gray's Parkway requires installation of new streets lighting; and

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to install new LED streetlights on black, banner-strength poles with concrete bases along the project; and

WHEREAS, the proposal provides that MidAmerican Energy Company's estimated cost to relocate the overhead utilities underground is \$139,738.85; and

WHEREAS, the proposal provides that since the estimated cost of construction is over \$100,000, the City is required by tariff to pay actual costs upon completion of the work, which could result in an additional charge or refund to the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the proposal from MidAmerican Energy Company to the City of Des Moines for installation of new LED streetlights for Gray's Parkway Extension, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content, and accepted.
2. That the Mayor is hereby authorized and directed to sign the proposal for and on behalf of the City of Des Moines, Iowa.
3. That the Engineering Department is authorized to administer the terms specified in the proposal.
4. That the Finance Director is authorized to make payment to MidAmerican Energy Company upon receipt of an invoice acceptable to the Engineering Department.

The estimated cost of this installation is **\$139,738.85**. Since the estimated cost of this project is over \$100,000.00, the City is required, by tariff, to pay actual costs upon completion of the work, which could result in an additional charge or refund to the City. Actual cost will be billed to the City upon completion of our installation. This proposal is valid for 90 days and if MidAmerican Energy Company construction has not commenced within 12 months, it may be voided.

These lights will be installed on steel poles and served by underground conductors, but will be billed to the City at the wood pole, overhead rate because the City has agreed to pay the streetlight facilities charge.

MidAmerican Energy Company's streetlight proposal is based on the approved street light analysis provided by the City. MidAmerican Energy Company will install the lights based on the staked locations provided in the field by the City.

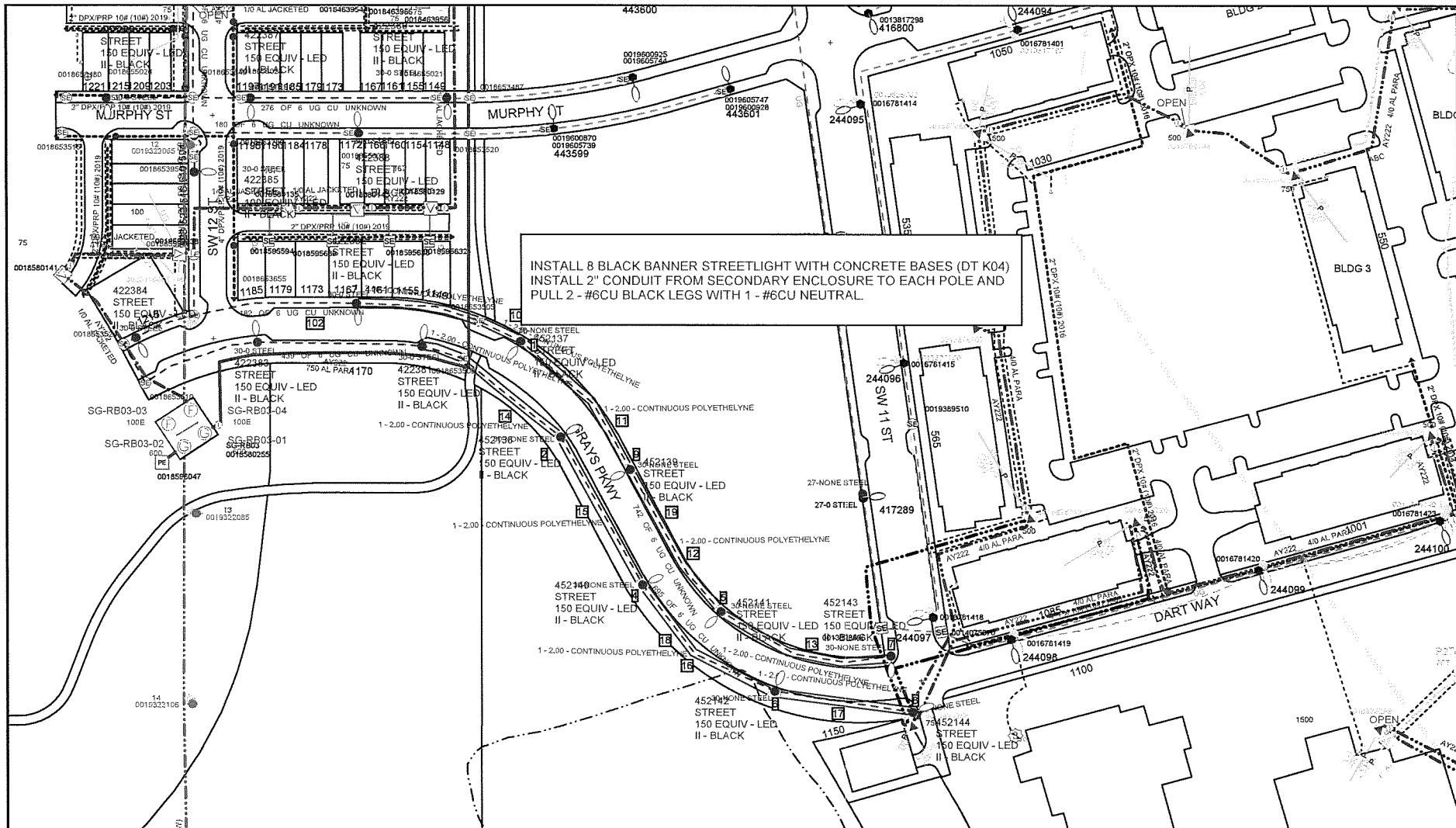
