**RESOLUTION APPROVING THE PURCHASE OF
MICROSOFT ENTERPRISE SOFTWARE SUPPORT SERVICES FROM
INSIGHT PUBLIC SECTOR, INC., AND APPROVING USE OF
OMNIA PARTNERS CONTRACT #4400006644 AND AGREEMENT WITH
INSIGHT PUBLIC SECTOR, INC.**

WHEREAS, the Information Technology Department has requested the Finance Department’s Procurement Division to issue a purchase order for the purchase of Microsoft Enterprise software support services for a use term of three years, from May 1, 2022 to April 30, 2025, pursuant to an updated Microsoft Enterprise Enrollment agreement; and

WHEREAS, the Procurement Administrator has determined that the requested Microsoft Enterprise software support services have been competitively procured and are available from Insight Public Sectors, Inc. (Joyce Mullen, President and CEO, 910 W. Carver Rd., Tempe, AZ 85284) through a cooperative group contracting consortium for State governments, specifically through Omnia Partners using Fairfax County, Virginia Contract #4400006644; and

WHEREAS, Des Moines Municipal Code Section 2-726(m) provides for the procurement of goods or services that have been competitively established through cooperative group contracting consortiums for State government departments, institutions, agencies and political subdivisions, such as Omnia Partners through Fairfax County, Virginia, without conforming to the competitive bidding requirements of the Procurement Division; and

WHEREAS, the Microsoft Enterprise software support services will be purchased from Insight Public Sector, Inc. for a three-year period in the estimated annual amount of \$662,630.46 using Omnia Partners Contract #4400006644; and

WHEREAS, said purchase is subject to an updated Microsoft Enterprise Enrollment agreement between the City and Microsoft Corporation, and is further subject to a Short Form Agreement – City Contract No. K22-402 between the City and Insight Public Sector, Inc., supplementing said Omnia Partners Contract with terms specific to the City’s procurement, with both agreements in form on file in the office of the City Clerk and as negotiated by the City’s Finance and Information Technology Departments; and

WHEREAS, annual funding for said purchase is available from the FY2022 Adopted Operating Budget, Information Technology Department, Enterprise Application Development, G001, IT152000, page 117.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

1. The purchase of Microsoft Enterprise software support services, at an estimated annual cost of \$662,630.46 for a three-year term from May 1, 2022 to April 30, 2025, per the

- general terms and pricing of Omnia Partners Contract ##4400006644 with Insight Public Sector, Inc., is hereby approved.
2. Subject to receipt of executed documents from the vendor, the Microsoft Enterprise Enrollment agreement by and between the City and Microsoft Corporation, in form on file in the office of the City Clerk, is hereby approved, and the Information Technology Director is hereby authorized and directed to execute said Agreement and to approve and sign any further implementing or license agreements thereunder on behalf of the City, subject to approval as to form by the Legal Department.
 3. Subject to receipt of executed documents from the vendor, the Short-Form Agreement – City Contract No. K22-402 between the City and Insight Public Sector, Inc., in form on file in the office of the City Clerk, supplementing Omnia Partners Contract # 4400006644 with terms specific to the City’s procurement, is hereby approved, and the Mayor is directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.
