WHEREAS, the low-dollar compliant quote was received from Truck Equipment, Inc., 1560 NE 44th Avenue, Des Moines, IA 50316, Terry Wieseler, President, in the amount of \$55,902.00; and

WHEREAS, funding is available from Engineering Road Use Replacement Fund FN024881, for a total cost of \$55,902.00 in accordance with said quote; and

WHEREAS, the Procurement Administrator and the Fleet Division recommend approval of the low-dollar compliant quote submitted by Truck Equipment, Inc. for service body upfitting as described herein.

APPROVING PROCUREMENT OF TRASH REMOVAL SERVICES AT SPRING CLEANUP TO REMOVE URBAN BLIGHT (SCRUB) EVENTS BY AGREEMENT WITH WASTE MANAGEMENT OF IOWA, INC.

WHEREAS, the Public Works Department has requested the Finance Department, Procurement Division to solicit bids for an annual contract with four additional one-year renewal options to furnish trash removal services for the Spring Cleanup to Remove Urban Blight (SCRUB) program; and

WHEREAS, the Procurement Division solicited bids by advertisement and emailing Request for Bid D22-339 to five (5) potential bidders with one (1) bid received; and

WHEREAS, the low-dollar compliant bid was received from Waste Management of Iowa, 201 SE 18th Street, Des Moines, IA 50317, David Steiner, President, in amounts per pull, per hour, and per ton dependent upon type of material and location of SCRUB event; and

WHEREAS, funding is available from PW250430/Solid Waste Operations, for an estimated annual cost of \$75,000.00 based on the services anticipated and the hourly and per-service bid submitted by Waste Management of Iowa; and

WHEREAS, the Procurement Administrator and the Public Works Department recommends approval of the low-dollar compliant bid and of execution of a short-form agreement between the City, through its Procurement Division, and Waste Management of Iowa documenting the services to be provided and per-pull, per-hour and per-service/location cost thereof.

NOW, THEREFORE, BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the award to Waste Management of Iowa for trash removal services at SCRUB events in response to Request for Bid D22-339, and further authorizes the Procurement Administrator to enter into a short-form agreement with said service provider effective May 25, 2022 to February 23, 2023, with the option to renew for four additional one-year periods.
