PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON CITY-WIDE PAVEMENT MARKING PROGRAM; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS QUALITY STRIPING, INC., JAMIE JIRAK, PRESIDENT, \$266,180.00

WHEREAS, on April 4, 2022, under Roll Call No. 22-0514, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

City-Wide Pavement Marking Program, 042022018

The project will include installing pavement markings, traffic control and other incidental items; all in accordance with the contract documents, including Plan File No. 642-001/032 at the following locations in Des Moines, Iowa

- University Avenue from 25th Street to 31st Street
- Franklin Avenue from 48th Street to Merle Hay Road
- Euclid Avenue from 2nd Ave to 12th Street
- Oak Park Avenue from 6th Avenue to 11th Street
- 11th Street from Oak Park Avenue to Clinton Avenue
- Clinton Avenue from 6th Avenue to 11th Street

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

WHEREAS, in accordance with said notice, those interested in said proposed plans, specifications, form of contract documents, and Engineer's estimate of construction cost both for and against, have been given opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the upon due consideration of the facts, and any and all statements of interested persons, any objections to the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement are overruled and the hearing is closed and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are hereby approved.

BE IT FURTHER RESOLVED: That sealed bids for said improvement were submitted by the following bidders:

- Quality Striping, Inc., Des Moines, IA Low Bid
- Iowa Plains Signing, Inc., Slater, IA

which were received and opened at a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on April 19, 2022. Said bids and the attached tabulation of bids for said improvement be and are hereby received and filed.

BE IT FURTHER RESOLVED: That the Des Moines City Engineer, as the Engineer, has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Quality Striping, Inc., Jamie Jirak, President, 1704 E. Euclid Ave., Des Moines, IA, 50313 in the amount of \$266,180.00, and said bid be and the same is hereby accepted.
