**APPROVE EXPANSION OF BROOK RUN NEIGHBORHOOD BOUNDARIES IN ACCORDANCE WITH THE NEIGHBORHOOD RECOGNITION POLICY**

**WHEREAS**, on May 24, 1993, by Roll Call No. 93-2026, the City Council approve the Neighborhood Recognition Policy which establishes for formal recognition of neighborhoods by the City of Des Moines, and authorizes recognized neighborhoods to advise the City on issues of concern; and

**WHEREAS**, on February 9, 2009, by Roll Call No. 09-180, the City Council approved designation of the Brook Run Neighborhood as a Recognized Neighborhood for the City of Des Moines; and

**WHEREAS**, the Brook Run Neighborhood has requested a boundary expansion to include NE 38<sup>th</sup> Avenue/East Douglas Avenue between East 49<sup>th</sup> Street and East 56<sup>th</sup> Street to the north, Stream Side Circle between East 49<sup>th</sup> Street and East 53<sup>rd</sup> Court and Brook Landing Court between East 53<sup>rd</sup> Court and East 56<sup>th</sup> Street to the south, East 56<sup>th</sup> Street between East Douglas Avenue and Brook Landing Court to the east, and East 49<sup>th</sup> Street between NE 38<sup>th</sup> Avenue/East Douglas Avenue and Stream Side Circle to the west, as specifically shown in the accompanying map; and

**WHEREAS**, on June 1, 2022, the Neighborhood Revitalization Board voted to recommend to the City Council that the City of Des Moines expand the boundaries of the Brook Run Neighborhood as proposed.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that the boundaries of the Brook Run Neighborhood be hereby expanded to include boundaries for proposed expansion includes NE 38<sup>th</sup> Avenue/East Douglas Avenue between East 49<sup>th</sup> Street and East 56<sup>th</sup> Street to the north, Stream Side Circle between East 49<sup>th</sup> Street and East 53<sup>rd</sup> Court and Brook Landing Court between East 53<sup>rd</sup> Court and East 56<sup>th</sup> Street to the south, East 56<sup>th</sup> Street between East Douglas Avenue and Brook Landing Court to the east, and East 49<sup>th</sup> Street between NE 38<sup>th</sup> Avenue/East Douglas Avenue and Stream Side Circle to the west, and in accordance with the Neighborhood Recognition Policy, effective immediately.
