SUMMARY OF ORDINANCE NO.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Chapter 114 Traffic and Vehicle Regulations, by amending Sections 114-2691, 114-2693, 114-2704, 114-2707, 114-2723, 114-3424, and 114-3787, as summarized below. DES MOINES TRAFFIC REGULATION CHANGES

Amending Chapter 114 of the Municipal Code regarding Traffic Regulation changes as follows:

- A. Code modification related to parking changes on Willowmere Drive between 61st Street and 63rd Street.
- B. Code modification to modify time of day parking restrictions on Ninth Street between Grand Avenue to High Street.
- C. Code modification to remove time of day parking restriction on west side of Ninth Street between Pleasant Street to Chestnut Street.
- D. Code modifications to remove time of day parking restrictions on west side of Tenth Street between Walnut Street to Locust Street.
- E. Code modifications to remove time of day parking restrictions on east side of Tenth Street between High Street to Woodland Avenue.
- F. Code modifications to remove time of day parking restrictions on west side of Twelfth Street between Cherry Street to Walnut Street.
- Avenue to Seventh Street.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That Sections 114-2691, 114-2693, 114-2704, 114-2707, 114-2723, 114-3424, and 114-3787, relating to traffic and vehicle regulations of the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is amended, as follows:

Sec. 114-2691. Ninth Street--Grand Avenue to High Street.

Ninth Street, on the east side, from Grand Avenue to High Street, no parking any time. Ninth Street, on the west side, from Grand Avenue to a point 155 feet north thereof, no parking any time.

Ninth Street, on the west side, from a point 155 feet north of Grand Avenue to High Street, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.

Sec. 114-2693. Ninth Street--Pleasant Street to Chestnut Street.

Ninth Street, on the west side, from a point 180 feet north of Pleasant Street to a point 50 feet north thereof, commercial loading zone.

Ninth Street, on the east side, from Pleasant Street to Chestnut Street, no parking 7:00 a.m. to 9:00 a.m.

Ninth Street, on the east side, from Pleasant Street to Chestnut Street, no parking 4:00 p.m. to 6:00 p.m.

Sec. 114-2704. Tenth Street--Walnut Street to Locust Street.

Tenth Street, on the west side, from Locust Street to a point 30 feet south thereof, no parking any time.

Tenth Street, on the west side, from Walnut Street to a point 28 feet north thereof, no parking any time.

Tenth Street, on the east side, from Walnut Street to Locust Street, no parking 4:00 p.m. to 6:00 p.m.

Tenth Street, on the east side, from Walnut Street to Locust Street, school passenger loading and unloading, 7:00 a.m. to 9:00 a.m. and 3:00 p.m. to 4:00 p.m. school days, except on Wednesday, from 7:00 a.m. to 9:00 a.m. and 1:00 p.m. to 3:00 p.m. when school early-out loading and unloading is allowed. An authorized school placard is required to identify vehicles dropping off and picking up during these restricted hours. Twenty-minute limit for all school loading and unloading.

Sec. 114-2707. Tenth Street--High Street to Woodland Avenue.

Tenth Street, on the west side, from High Street to a point 25 feet north thereof, no parking any time.

Tenth Street, on the west side, from Woodland Avenue to a point 35 feet south thereof, no parking any time.

Tenth Street, on the east side, from a point 140 feet north of High Street to a point 65 feet north thereof, no parking any time.

Tenth Street, on the east side, from Woodland Avenue to a point 34 feet south thereof, no parking any time.

Tenth Street, on the east side, from a point 205 feet north of High Street to a point 25 feet north thereof, commercial loading zone.

Sec. 114-2723. Twelfth Street--Cherry Street to Mulberry Street.

Twelfth Street, on the east side, from Cherry Street to a point 160 feet north thereof, no parking any time.

Twelfth Street, on the east side, from Mulberry Street to a point 25 feet south thereof, no parking any time.

Twelfth Street, on the west side, from Cherry Street to a point 25 feet north thereof, no parking any time.

Twelfth Street, on the west side, from Mulberry Street to a point 25 feet south thereof, no parking any time.

Sec. 114-3424. Locust Street--Sixth Avenue to Seventh Street.

Locust Street, on the south side, from a point 110 feet west of Sixth Avenue to a point 90 feet west thereof, commercial loading zone.

Locust Street, on the north side, from Sixth Avenue to a point 150 feet west thereof, no parking any time.

Sec. 114-3787. Willowmere Drive--Dead end north of Park Plaza Drive to Southwest Sixty-third Street.

Willowmere Drive, on the south side, from a point 280 feet north of Park Plaza and any part of the cul-de-sac to Southwest Twenty-third Street, no parking any time.

Willowmere Drive, on the north side, from a point 50 feet east of Fleur Drive to a point 50 feet west of Fleur Drive, no parking any time.

Willowmere Drive, on the south side, from Southwest Twenty-ninth Street to a point 50 feet west thereof, no parking any time.

Willowmere Drive, on the north side, from Southwest Twenty-ninth Street to Southwest Thirtieth Street, no parking any time.

Willowmere Drive, on both sides, from Southwest Sixty-first Street to a point 75 feet west thereof, no parking any time.

Willowmere Drive, on the south side, from a point 285 feet west of Southwest Sixty-first Street to a point 150 feet west thereof, no parking 8:00 a.m. to 5:00 p.m. Monday through Friday.

Willowmere Drive, on the south side, from a point 435 feet west of Southwest Sixty-first Street to Southwest Sixty-third Street, no parking any time.

Willowmere Drive, on the north side, from a point 120 feet east of Southwest Sixty-third Street to Southwest Sixty-third Street, no parking any time.

Willowmere Drive, on the north side, from a point 425 feet west of Southwest Sixty-first Street to a point 100 feet west thereof, no parking 8:00 a.m. to 5:00 p.m., Monday through Friday.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
