AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1312, 114-3168, 114-3292, and 114-3697, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That Sections 114-1312, 114-3168, 114-3292, and 114-3697, relating to traffic

and vehicle regulations of the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is amended, as follows:

Sec. 114-1312. Easton Boulevard.

Easton Boulevard, from East University Avenue to <u>the east city limits</u>East Twenty-fifth Street, 30 miles per hour.

Easton Boulevard, from East Twenty-fifth Street to the east city limits, 35 miles per hour.

Sec. 114-3168. Easton Boulevard--East University Avenue to east city limits.

Easton Boulevard, on <u>both</u>the south sides, from East University Avenue to a point 100 feet east thereof <u>East Twenty-second Street</u>, no parking any time.

Easton Boulevard, on both sides, from Dixon Avenue to a point 100 feet east of Stewart Street, no parking any time.

Easton Boulevard, on the north side, from East Nineteenth Street to a point 75 feet west thereof, no parking any time.

Easton Boulevard, from 100 feet west of Delaware Avenue/East Twenty-first Street to East Twenty-second Street, no parking any time.

Sec. 114-3292. Hartford Avenue--South Union Street to East Watrous Avenue.

Hartford Avenue, on the south side, from South Union Street to a point 100 feet east thereof, no parking any time.

Hartford Avenue, on the south side, from a point 100 feet east of South Union Street to Indianola Avenue, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

Hartford Avenue, on the south side, from Indianola Avenue to Southeast Third Street, no parking any time.

Hartford Avenue, on the north side, from South Union Street to a point 230 feet west of Southeast Sixth Street, no parking any time.

Hartford Avenue, on the north side, from Southeast Sixth Street to a point 100 feet east, no parking any time.

Hartford Avenue, on the north side, from a point 180 feet west of Southeast Eighth Court to a point 130 feet east of Southeast Eighth Court, no parking any time.

Hartford Avenue, on the south side, from a point 150 feet west of Southeast Fifth Street to a point 50 feet east of Southeast Fourteenth Street, no parking any time.

Hartford Avenue, on the north side, from a point 230 feet west of Southeast Fourteenth Street to a point 50 feet east of Southeast Fourteenth Street, no parking any time.

Hartford Avenue, on the north side, from Southeast Fourteenth Street to a point 50 feet east thereof, no parking any time.

Hartford Avenue, on the south side, from Southeast Fourteenth Street to a point 50 feet east thereof, no parking any time.

Hartford Avenue, on both sides, from Southeast <u>Eighteenth Fourteenth</u> Street to <u>2700 feet</u> <u>east of</u> Southeast Twenty-second Street, no parking any time.

Sec. 114-3697. Urbandale Avenue--Martin Luther King Jr Parkway to Forty-fourth Street.

Urbandale Avenue, on both sides, from Martin Luther King Jr Parkway to Thirtieth Street, no parking any time.

Urbandale Avenue, on both sides, from Leado Avenue to Thirty-fourth Street, no parking any time.

Urbandale Avenue, on the south side, from a point 120 feet west of Thirty-fourth Street to Thirty-fourth Street, no parking any time.

Urbandale Avenue, on the south side, from Thirty-eighth Street to a point 75 feet east thereof, no parking any time.

Urbandale Avenue, on the south side, from Thirty-eighth Street to a point 75 feet west thereof, no parking any time.

Urbandale Avenue, on the south side, from Beaver Avenue to appoint 85 feet east thereof, no parking any time.

Urbandale Avenue, on the south side, from a point 185 feet east of Beaver Avenue to Thirty-Ninth Street, no parking any time.

Urbandale Avenue, on the north side, from a point 70 feet east of Beaver Avenue to Fortyfirst Place, no parking any time.

Urbandale Avenue, on the north side, from Beaver Avenue to a point 490 feet east thereof, no parking any time.

Urbandale Avenue, on the south side, from <u>a point 85 feet east of</u> Beaver Avenue to a point <u>130-50</u> feet west <u>of Forty-first Placethereof</u>, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and

publication as provided by law.
