**RESOLUTION APPROVING THE PURCHASE OF  
TWO (2) REPLACEMENT AUTOMATED COLLECTION SYSTEM CONTAINERS  
FROM MACQUEEN EQUIPMENT, AND APPROVING USE OF SOURCEWELL  
CONTRACT NUMBER 091219-THC**

**WHEREAS**, the Fleet Services Division has requested the Finance Department's Procurement Division to issue a purchase order for the purchase of two (2) replacement automated collection system containers for use by the Sanitation Division of the Department of Public Works; and

**WHEREAS**, the Procurement Administrator has determined that the requested automated collection system containers have been competitively bid and are available from MacQueen Equipment, Inc. (Dan Gage, President/CEO), 4607 SE Rio Ct, Ankeny, IA 50021, an authorized distributor of The Heil Co., using Sourcewell Contract Number 091219-THC; and

**WHEREAS**, Des Moines Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

**WHEREAS**, the two (2) replacement automated collection system containers are being purchased from MacQueen Equipment, Inc., an authorized distributor of The Heil Co., in the amount of \$81,350.48 utilizing the Sourcewell Contract Number 091219-THC; and

**WHEREAS**, funding for the replacement automated collection system containers is available from Fiscal Year 2023 operating budget. I010 FN024024 Equipment Replacement Fund page 80.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Des Moines, Iowa, that:

1. The purchase of two (2) replacement automated collection system containers for use by the Sanitation Division of the Department of Public Works from MacQueen Equipment, Inc., at a total cost of \$81,350.48 using Sourcewell Contract Number 091219-THC is hereby approved.
2. The Finance Department is hereby directed to proceed with negotiation of any agreements or amendments deemed necessary to the existing contract number 091219-THC between Sourcewell and The Heil Co.


