RESOLUTION APPROVING ADMISSION OF THE CITY OF URBANDALE TO THE GREATER DES MOINES SISTER CITIES COMMISSION

WHEREAS, the cities of Des Moines, Windsor Heights, Norwalk, Johnston, Cumming and Ankeny have entered into the *Intergovernmental Agreement Creating the Metropolitan Sister Cities Commission* (the "Agreement") for the purposes of establishing the Metropolitan Des Moines Sister Cities Commission, now known as the Greater Des Moines Sister Cities Commission, and continue to be participating members of the Commission; and,

WHEREAS, the City of Urbandale desires to join in the Greater Des Moines Sister Cities Commission and has signed the Agreement in the standard form; and,

WHEREAS, the Agreement provides that additional municipalities may be added to membership of the Commission upon approval by a majority of the six (6) cities now participating on the Commission.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. The City of Des Moines hereby gives its approval for the admission of Urbandale to the Greater Des Moines Sister Cities Commission, subject to three (3) of the other participating cities joining in such approval.
2. Upon approval of the admission of Urbandale to the Greater Des Moines Sister Cities Commission by three (3) of the other participating cities, the Mayor and City Clerk are hereby authorized and directed to sign the Agreement with Urbandale on behalf of the City of Des Moines.

WHEREAS, the City of Urbandale has requested to be added to the Commission and the City of Norwalk desires to approve the addition of the City of Urbandale to the commission;


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Norwalk, Iowa, as follows:






WHEREAS, the City of Urbandale, Iowa has requested that it be added to the Sister Cities Commission, and


