**APPROVING \$200,000.00 OF ADDITIONAL FUNDS FOR THE PURCHASE OF SOLID WASTE COLLECTION CARTS FROM TOTER, INC. UTILIZING SOURCEWELL CONTRACT #041521-TOT TO BE USED BY PUBLIC WORKS DEPARTMENT FOR A TOTAL ESTIMATED ANNUAL AMOUNT OF \$708,000.00**

**WHEREAS**, the Solid Waste Division of the Public Works Department previously requested the Finance Department, Procurement Division to issue blanket purchase orders for solid waste collection carts compatible with existing solid waste trucks to be purchased during fiscal year 2023; and

**WHEREAS**, the Procurement Administrator determined that the requested solid waste carts were competitively bid and available from Toter, Inc., 841 Meachum Road, Statesville, NC 28687, Chad Coauette, Executive Director/CEO, per Sourcewell Contract #041521-TOT; and

**WHEREAS**, Roll Call 22-1161, dated July 18, 2022, approved the use of Sourcewell Contract #041521-TOT for the purchase of solid waste collection carts from Toter, Inc. and authorized expenditures at an annual estimated amount of \$508,000.00 from PW250430, Solid Waste Collection, and PW250432, Curbside Recycling, Public Works Divisions Operating and CIP Budgets; and

**WHEREAS**, additional spending in the amount of \$200,000.00 is anticipated for the remainder of fiscal year 2023 for the purchase of additional solid waste collection carts to meet customer demand; and

**WHEREAS**, \$200,000.00 of additional funding is available from Operating Budget, Solid Waste Collection, Org PW250430 and Curbside Recycling Org PW250432.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Des Moines, Iowa, that the additional expenditure of \$200,000.00 for the purchase of solid waste carts from Toter, Inc. for the remainder of fiscal year 2023, at a total estimated annual amount of \$708,000.00 and pursuant to the general terms and pricing of Sourcewell Contract #041521-TOT for use by the Public Works Department as described above, is hereby approved.
