RESOLUTION SETTING DATE OF HEARING TO ADOPT A RESOLUTION ESTABLISHING THE TOTAL MAXIMUM PROPERTY TAX DOLLARS CERTIFIED FOR LEVY FOR THE FISCAL YEAR ENDING JUNE 30, 2024

WHEREAS, Iowa Code Section 384.15A requires a public hearing for City Council adoption of a resolution establishing the total maximum property tax dollars that may be certified for levy including the property tax levies specified in Iowa Code Subsection 384.15A(2).

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

- 1. The public hearing on the City Council adoption of the resolution establishing the total maximum property tax dollars that may be certified for levy for the fiscal year ending June 30, 2024 is hereby fixed and set for February 20, 2023 at 5:00 p.m. in the 2nd Floor, MSC Board Room, Richard A. Clark Municipal Services Center, 1551 E. M.L. King Jr. Parkway, Des Moines, Iowa at which time any resident or property owner of the City may present oral or written objections.
2. The City Clerk be and is hereby authorized and directed to publish notice of said public hearing in the attached form as prescribed by the State of Iowa Department of Management in the Des Moines Register, a newspaper of general circulation in the City of Des Moines, Polk County, Iowa, on February 8, 2023 all in accordance with Iowa Code Subsection 384.15A(4), requiring publication not less than ten (10) nor more than twenty (20) days prior to the date set forth for said hearing.
3. The City Manager or his designee is hereby directed to post and clearly identify the notice of said public hearing in the form attached on the City internet website for public viewing beginning on February 8, 2023, and is hereby further directed to post such notice or an electronic link to such notice on each social media account maintained by the City on February 8, 2023.
