HOLD HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF A PORTION OF VACATED ALLEY RIGHT-OF-WAY LOCATED EAST OF AND ADJOINING 835 41ST STREET TO SARAH J. MCCURDY

WHEREAS, on November 21, 1935, the City Council of the City of Des Moines, Iowa passed Ordinance No. 4312 vacating all of the north-south alley right-of-way lying between 41st Street and 40th Place extending from Rollins Avenue to Center Street; and

WHEREAS, Section 2 of Ordinance No. 4312 states, "That said alley or strip of ground above described shall revert to the abutting property owners, one half on each side of the center line thereof;" and

WHEREAS, the City of Des Moines Real Estate Division can find no evidence that a deed from the City to the owner of 835 41st Street was ever filed of record with the Office of the Polk County Recorder; and

WHEREAS, Sarah J. McCurdy, current owner of 835 41st Street, has asked the City of Des Moines ("City") to approve and file of record a quit claim deed conveying to her the west seven (7) feet of the vacated alley right-of-way lying east of and adjoining her property at 835 41st Street in order to correct the chain of title to her property, clear a legal title objection, and allow her to close on the sale of 835 41st Street; and

WHEREAS, there is no known current or future public need for the Property proposed to be sold, and the City will not be inconvenienced by the sale and conveyance of said Property; and

WHEREAS, on March 27, 2023 by Roll Call No. 23-0391, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed conveyance be set down for hearing on April 10, 2023, at 5:00 p.m., in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and

WHEREAS, due notice of said proposal to convey the Property was given to all necessary parties as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

7. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed conveyance of the west half of the vacated north-south alley right-of-way lying east of and adjoining 835 41st Street, Des Moines, Iowa, as described herein, are hereby overruled and the hearing is closed.

The Real Estate Division Manager is authorized and directed to forward the original of the Quit Claim Deed, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Polk County Recorder's Office for the purpose of causing these documents to be recorded.
- 6. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the original of the Quit Claim Deed.
- 7. There are no proceeds associated with his transaction.
