## APPROVING WATER QUALITY INITIATIVE URBAN CONSERVATION DEMONSTRATION PROJECTS COST-SHARE GRANT CONTRACT WITH IOWA DEPARTMENT OF AGRICULTURE AND LAND STEWARDSHIP IN THE AMOUNT OF \$250,000 FOR THE GLENDALE CEMETERY WET POND REHABILITATION PROJECT

**WHEREAS**, the Parks and Recration Department submitted an application to the Iowa Department of Agriculture and Land Stewardship for a Water Quality Initiative Targeted Demonstration Watershed project grant for the Glendale Cemetery Wet Pond Rehabilitation for the City's Glendale Cemetery Wet Pond Rehabilitation project ("Project"); and

WHEREAS, Iowa Department of Agriculture and Land Stewardship (IDALS) has approved the City's Water Quality Initiative grant application for the Project in the amount of \$250,000.00 and has prepared a Cost-Share Grant Contract for such Project, a copy of which is on file in the City Clerk's Office, which Contract includes, among other terms, the obligation of the City to indemnify IDALS in regard to the Contract including City's activities with subgrantees and third parties in regard to the Contract and conflict of interest prohibitions; and

**WHEREAS**, the Public Works Department recommends approval of this Contract as the Project should result in improved water quality in the Glendale Cemetery pond, the Waveland Creek watershed, the Waveland Golf Course pond, Walnut Creek and the Raccoon River.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The Water Quality Initiative Urban Conservation Demonstration Projects Cost-Share Grant Contract between the City and IDALS for the Project for a grant of \$250,000.00, in form on file in the office of the City Clerk, is hereby approved and the Mayor is hereby authorized and directed to sign said Contract.

2. The City Engineer and Park and Recreation Department Director and respective designees are authorized and directed to administer said Agreement and monitor compliance thereof on behalf of the City.
