**RESOLUTION APPROVING THE PURCHASE OF
REPLACEMENT CONSTRUCTION EQUIPMENT FROM ZIEGLER
CAT INC., AND APPROVING USE OF SOURCEWELL
CONTRACT NUMBER 032119-CAT**

WHEREAS, the Fleet Services Division has requested the Finance Department's Procurement Division to issue a purchase order for the purchase three (3) replacement compact track loaders, one (1) replacement mini-hydraulic excavator for use in various divisions of the Department of Public Works and Parks and Recreation Department; and

WHEREAS, the Procurement Administrator has determined that the replacement construction equipment has been competitively bid and is available from Ziegler CAT Inc., 1500 Ziegler Drive, Altoona, IA 50009, William Hoeft, (President), using Sourcewell Contract Number 032119-CAT; and

WHEREAS, Des Moines Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the three (3) replacement compact track loaders, one (1) replacement mini-hydraulic excavator are being purchased from Ziegler CAT Inc., in the amount of \$414,716.56 utilizing the Sourcewell Contract Number 032119-CAT; and

WHEREAS, funding is available from 2023-2024 Operating Budget, Equipment Replacement Fund, Page 80.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

1. The purchase of three (3) replacement compact track loaders, one (1) replacement mini-hydraulic excavator for use in various divisions of the Department of Public Works and Parks and Recreation Department from Ziegler CAT Inc., at a total cost of \$414,716.56 using Sourcewell Contract Number 032119-CAT is hereby approved.
2. To the extent determined necessary by the Legal Department and the Finance Department, the Finance Department and Fleet Division are hereby authorized and directed to proceed with negotiation of a Short Form Agreement or similar agreement between the City and Ziegler CAT Inc., supplementing Sourcewell Contract No. 032119-CAT, and the Finance Director is authorized and directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.


