## APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE PROCESS FOR GOOD CAUSE, AND AUTHORIZING NEGOTIATION AND EXECUTION OF AGREEMENT WITH INTERGRAPH CORPORATION D/B/A HEXAGON SAFETY INFRASTRUCTURE FOR COMPUTER AIDED DISPATCH SYSTEM

**WHEREAS**, on February 27, 2012, by Roll Call No. 12-0309, the City Council approved an upgrade to the City's Computer Aided Dispatch (CAD) System and the addition of an incident reporting program (IFRLE); and

**WHEREAS**, on June 12, 2017, by Roll Call 17-0999, the City Council approved procurement of a system upgrade to the City's CAD System from Intergraph Corporation (d/b/a Hexagon Safety Infrastructure, 305 Intergraph Way, Madison AL 35758, Steven Cost, President)("Hexagon"), and authorized the City Manager to negotiate and execute a Master Services Agreement with Hexagon; and

**WHEREAS**, the parties desire to extend the services provided by Hexagon for up to a five and one-half (5.5) year period with up to three 1-year renewal options, and are negotiating a Master Agreement and Primary Contracting Document, in substantially the form on file with the City Clerk, with proposed initial and renewal terms through June 30, 2032; and

**WHEREAS**, the City Manager recommends that the procurement of the CAD System from Hexagon be exempted from the competitive procurement requirements for good cause shown, pursuant to Section 2-710(b) of the Municipal Code of the City of Des Moines; and

WHEREAS, funding is available from FY 2024 Adopted Operating Budget, General Fund.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Des Moines, Iowa, that:

1. Good cause has been shown to exempt the procurement of the above Computer Aided Dispatch (CAD) System from the City's Procurement Ordinance competitive procurement requirement.

2. The Master Agreement and Primary Contracting Document for the City's CAD System by and between the City of Des Moines, Iowa and Intergraph Corporation d/b/a Hexagon Safety Infrastructure, are hereby approved in substantially the form on file in the office of the City Clerk, and the Information Technology Department Director and Finance Director and their designees are authorized and directed to complete negotiation with Intergraph Corporation d/b/a Hexagon Safety Infrastructure and to administer and monitor said Agreement on behalf of the City.

3. Following approval as to form by the Legal Department of said Agreement and Primary Contracting Document, the City Manager is hereby authorized and directed to execute said Agreement and Document, and to consider, approve and execute renewal addenda on behalf of the City through June 30, 2032, if the City Manager deems such renewal(s) to be in the best interest of the City.
